

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to atlantakravmaga.com and Atlanta Krav Maga and Fitness and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Atlanta Krav Maga and Fitness include atlantakravmaga.com, AKMF, Atlanta Kickboxing and Fitness, atlantakickboxingandfitness.com and atlantakickboxingandfitness.com. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AKMF may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase AKMF's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
